

**Triple-S Propiedad** values you as one of our customers; therefore, we wish to inform you about our privacy policy.

In accordance with the Federal Gramm-Leach-Bliley Act (hereinafter, the "law"), and Rule 75 of the Office of the Commissioner of Insurance (the "rule") we detail below our practices on the management of your non-public personal financial information (hereinafter "personal information"). We always safeguard and protect the information that you share with us. This privacy policy includes examples of the type of personal information we usually collect and the companies with which, on a limited basis, we share that information with. The examples are illustrative and should not be considered a complete inventory of our collection, use and disclosure of information.

### 1. Information we Gather

We may gather personal information from different sources, which include the following:

- a) Information that you have provided on applications and other forms or documents to obtain insurance products or services, such as, your name, address, Social Security number, income and beneficiaries.
- Information related to your transactions with us and with our affiliates such as your insurance coverage, premium payments and payment history.
- Information provided to us by consumer credit bureaus, for example, information about your credit history and credit worthiness.

## 2. Information we Share

Occasionally, we may share the information described above, as permitted by law and the rule, with the following people:

- a) Affiliates engaged in the sale of property/casualty, accident, life and health insurance.
- b) Financial services providers, such as producers, authorized representatives and general insurance agents.
- c) Non-financial companies, such as companies providing document delivery service by mail.
- d) Marketing companies that provide us with direct marketing and telemarketing services to offer our products. We require that these companies sign written agreements by which the companies are obligated to maintain the confidentiality of shared information and limit its use to the purposes for which we disclosed the information.

### 3. Information of Former Customers

**Triple-S Propiedad** shares the personal information of our past customers in the same manner as we do with our current customers.

## 4. Security Measures

**Triple-S Propiedad** limits the internal access to your personal information only to those employees who require it to provide products and services to our customers. We place responsibility on our employees to comply with our privacy policy and its principles. In addition to the foregoing, we maintain physical and electronic security measures to safeguard the confidentiality of your information, as required by law, rule and our privacy policy.

#### 5. Health Information

We share your health information in accordance with the parameters imposed by the law and the rule. For example, in the management and adjustment of claims and to detect, investigate or report fraud or misrepresentation.

# 6. Changes in Privacy Policy

**Triple-S Propiedad** reserves the right to modify or amend this privacy policy. In the event of any significant changes, we will proceed to send you a revised notice describing the modifications and amendments.

## 7. Opt Out Option

If you consent that your personal information can be shared with non-affiliated companies, do not return this document.

To prohibit that your personal information can be shared with unaffiliated companies, simply complete the Opt Out Application which is included below and send it to the following address: Triple-S Propiedad, Compliance Office, PO Box 70313, San Juan, Puerto Rico 00936-0313.

In cases of joint clients, such as joint holders of insurance policies, if one of the clients chooses the exclusion, it will be applied equally to all customers of this policy.
